**Tuition Fees** are calculated in accordance with recommendations set by Brisbane Catholic Education and these fees contribute towards the operating costs of the College.

The **Student Levy** is charged per student and supports the provision of curriculum resources, student equipment, routine compulsory excursions and camps, Religious Education activities and general costs relating to other student activities.

The **Information Technology Levy** is charged per student and supports the provision of the 1:1 Laptop Program. New laptops are issued to all Year 7 and Year 10 students and remain the property of the College. Please refer to our College 1:1 Laptop Program Policy for full details. (Please note this levy does not currently cover the full cost of the laptop provided to students).

The **Capital Levy** provides essential support for the capital development and asset maintenance necessary to allow St Michael's College to continue to develop as a school of excellence. This levy is a **compulsory** charge and is **not tax deductible**.

The **Family and Community Engagement (FACE) Levy** is charged per family on behalf of the FACE Group to support all students through facility enhancements (eg: air conditioning) and to subsidise College representation (eg: representative sport at a state or national level).

**Vocational Education & Training Courses** If your child is enrolling in a VET course in 2024, please be advised that Certificate Course Fees apply (refer to the Senior Subject Course Guide issued in Year 11).

## **School Fees Payment**

The annual Fees and Levies are billed over the four terms - Statement of Fees and Levies are issued at the beginning of each term, with settlement required by the due date which is generally within 14 days and is noted on the statement.

### **Payment via Instalment Arrangement**

The College's *preferred method* of payment is via an *instalment arrangement* whereby the total annual school fees are settled by several payments spread over the period February to November. This can be 10 monthly instalments, 20 fortnightly instalments or 40 weekly instalments. The options are:

**Direct Debit** – regular payment from a bank account – please complete the attached form.

Credit Card – regular payment from a credit card – please complete the attached form.

### **Other Payment Methods:**

BPay - The Biller Code and Reference Number are noted on the Statement of Fees and Levies.

**Bpoint** – The link to this payment site can be found on the Parent Portal.
